Reservations and Deposit

Reservations must be received before May 15, 2022. Please send payment to Jerusalem Peacebuilders, 6221 Main Street, Houston, TX 77030, payable to *Jerusalem Peacebuilders*. A deposit of 40% of the total price (of which \$250 is non-refundable) is required to hold the reservation.

Payment

Final payment is due before July 1, 2022. You will be invoiced accordingly.



PILGRIMAGE PRICE AND PACKAGE DETAILS October 11 – 22, 2022

Cancellations and cancellation fees

For cancellations received more than 45 days prior to departure, the non-refundable portion of the deposit will be retained. For cancellations received within 45 days of departure, the following cancellation fees will apply:

45-30 days prior to departure:	40% of pilgrimage price
30-20 days prior to departure:	50% of pilgrimage price
19-5 days prior to departure:	75% of pilgrimage price
4 days or less before departure:	100% of pilgrimage price

Cancellation charges will be figured from the day written notice of the cancellation is received. If the organizers cancel the pilgrimage, all amounts paid will be refunded, less any non-refundable fees to travel agencies and hotels.

Visas and Vaccinations

Visas to enter Jordan and Israel are granted automatically for USA passport holders. Passports must be valid for the dates of travel and valid for least for 6 months after the return date. There are **no** medical requirements to enter Jordan or Israel.

Physical Requirements

Participants interested in this program should be in good health and able to walk at a moderate pace without assistance on uneven terrain.

Travel Insurance

Travel insurance is **not** included in the pilgrimage price. Participating pilgrims are **strongly encouraged** to purchase international travel insurance.

Orientation Materials

Approximately EIGHT WEEKS before departure you will receive an Information packet containing helpful information, the list of participants, and suggested readings.
