The undersigned (sometimes referred to herein as "I") has carefully read this Acknowledgement and Assumption of Risk and Release Agreement (this "Agreement") and understands that it affects the undersigned's legal rights and, if the Participant is a minor, the legal rights of the

Participant. This Agreement must be signed prior to the Participant taking part in any activities organized by Jerusalem PeaceBuilders, Inc., a Vermont non-profit corporation (“JPB”).

I acknowledge that the Participant will engage in a variety of activities organized by JPB that are hazardous (the “Activities”), e.g., if the Participant attends one of JPB’s summer camps, activities may include without limitation horseback riding, hiking, swimming and canoeing, and, if the Participant engages in program travel facilitated by JPB, activities may include without limitation travel in areas of armed conflict. Facilities, equipment and services provided by JPB, an affiliate of JPB or a third-party vendor or service provider, may be used in connection with the Activities. Each of the Activities presents certain risks that may result in loss or injury to the Participant, including loss of life. I have fully satisfied myself as to the nature of the Activities and the risks associated with each of the Activities. I agree to assume all risks of such loss or injury to the Participant.

I acknowledge that it is my responsibility to know my, or, if the Participant is a minor, the Participant’s, abilities and limitations and to comply with any safety standards, rules and policies set forth by JPB. I affirm that I or, if the Participant is a minor, the Participant is healthy and without limitation and that I know of no reason why my, or, if the Participant is a minor, Participant’s taking part in the Activities might cause injury or loss to me or, if the Participant is a minor, to the Participant or to other persons. If the Participant is a minor, I have discussed the Activities and their associated risks with the Participant, who understands them.

AUTHORIZATION EMERGENCY MEDICAL TREATMENT

In the event JPB determines that emergency medical treatment is appropriate due to illness or injury of the Participant, I authorize JPB personnel to:

1. Arrange for transportation and emergency medical treatment of the Participant; and
2. Release JPB records regarding the Participant to healthcare providers.

I agree to indemnify JPB for any costs or damages JPB incurs in connection such emergency medical treatment.

I, FOR MYSELF, IF THE PARTICIPANT IS A MINOR FOR THE PARTICIPANT AND FOR THE RESPECTIVE SUCCESSORS, ASSIGNS, PERSONAL REPRESENTATIVES AND HEIRS OF EACH OF US HEREBY FULLY ACQUIT, RELEASE AND FOREVER DISCHARGE JPB AND EACH OF ITS OFFICERS, DIRECTORS, EMPLOYEES, AFFILIATES, ATTORNEYS, AGENTS, SUCCESSORS AND ASSIGNS, AND ALL LANDOWNERS, LESSEES AND TENANTS IN PRIVY OF CONTRACT WITH ANY OF THEM, AS WELL AS THEIR AGENTS, CONTRACTORS AND EMPLOYEES (COLLECTIVELY "INDEMNITEES"), FROM ANY AND ALL CAUSES OF ACTION, CLAIMS, DEMANDS, SUITS OF WHATSOEVER KIND OR NATURE, LIABILITIES, DAMAGES, LOSSES AND EXPENSES, WHETHER KNOWN OR UNKNOWN, SUSPECTED OR UNSUSPECTED, FIXED OR CONTINGENT, LIQUIDATED OR UNLIQUIDATED, WHICH MAY NOW OR HEREAFTER EXIST, WITH RESPECT TO, ARISING OUT OF OR IN ANY WAY RELATING TO THE PROGRAMS OR OPERATIONS OF JPB,

INCLUDING WITHOUT LIMITATION THE ACTIVITIES.

I, FOR MYSELF, IF THE PARTICIPANT IS A MINOR FOR THE PARTICIPANT AND FOR THE RESPECTIVE SUCCESSORS, ASSIGNS, PERSONAL REPRESENTATIVES AND HEIRS OF EACH OF US HEREBY AGREE TO INDEMNIFY, DEFEND (WITH COUNSEL SELECTED BY THE INDEMNITEES), PROTECT AND HOLD HARMLESS EACH OF INDEMNITEES FROM AND AGAINST ANY AND ALL CAUSES OF ACTION, CLAIMS, LIABILITIES OR DAMAGES OF EVERY KIND INCURRED, ARISING OUT OF OR IN ANY WAY RELATING TO THE PARTICIPANT'S TAKING PART IN THE PROGRAMS OR OPERATIONS OF JPB, INCLUDING WITHOUT LIMITATION THE ACTIVITIES, REGARDLESS OF WHETHER SUCH ARE CAUSED BY OR ARISE FROM, IN WHOLE OR IN PART, THE SOLE NEGLIGENCE OR THE JOINT NEGLIGENCE OF ANY INDEMNITEE.

It is my express intent that the indemnity provided for herein is to indemnify and protect the Indemnitees from the consequences of the Indemnitees' own negligence, whether that negligence is the sole or a contributing cause of the injury or loss.

If any provision of this Agreement is invalid or unenforceable under applicable law, it shall not affect the validity or enforceability of the remainder of the terms of this Agreement, and without further action by the parties to this Agreement, such provision shall be reformed to the minimum extent necessary to make such provision valid and enforceable.

This Agreement and any matters arising from or relating to this Agreement shall be governed by and construed in accordance with the laws of the State of Vermont.
